#### INDEPENDENT AUDITOR'S REVIEW REPORT ON INTERIM FINANCIAL RESULTS

We have reviewed the accompanying statement of unaudited financial results of BNR Udyog Limited ("the Company") for the period ended 31st December 2022 and year to date results for the period 01st April 2022 to 31st December 2022 ("the statement").
